PLS INITIAL:

_____ I understand by signing this contract the performer is **committing to the participation of this event, and registration fees will not be refunded.** If the performer drops from this project after signing this contract, it is considered unprofessional in the entertainment industry.

_____ I understand the performer will need to be ready for sound check & director notes **30 MINUTES** before show time. This is called a CALL TIME. Failure to be signed in before the call time may result in the performer not performing unless special arrangements have been made prior with the instructor. All rules for this event are from the Actor's Equity Association Rule Book, the union for professional performers. These rules will be enforced at this event for educational purposes demonstrating the expectations in a professional or semi-professional career in the arts.

CALL TIME: 3:00pm - *time subject to change, students only*

_____ I understand by signing this contract the performer is committed to be at the event for the entirety of the show. **Late arrival and early departure will be disruptive to the show and inconsiderate to fellow performers.**

_____ I understand preferred performance order requests are not permitted. The lineup is at the discretion of the director of the show.

_____ I understand the dress for this event is "**dress to impress**" and the performer will provide attire for this event. Think: nice casual – semi formal. No over the top fancy dresses but no jeans and T-shirts either. You are encouraged to bring your outfits into your lesson for director feedback and to rehearse in them if you are unsure about what to wear.

_____ I understand it is the performer's responsibility to **invite family and friends to provide an audience for this event. A flyer will be emailed to invite family and friends.**

_____ I understand the performer should eat lunch prior to this event as refreshments will not be available. The performer should avoid dairy products before singing.

_____ I understand it is the performer's responsibility to **warm up prior to this event on their own.** A formal group warm-up will not be offered.
